**Fiscal Year 2017 - 2018 was again a year filled with amazing work done by dedicated and passionate employees. We saw wonderful commitment from staff, clients and volunteers in working toward our mission of Protecting Children, Strengthening Families and Preventing Child Abuse. We are thrilled to share the following accomplishments:
In Fiscal Year 17-18 Family Support Center served 2,556 individuals with 51,011 hours of direct care. This was accomplished by 55 employees, both full and part-time. The agency also had the support and assistance of 12,743 volunteer hours of service given by 1,068 unduplicated volunteers. Family Support Center is pleased to report that 87¢ of every dollar raised goes directly to program support.**

4b (Code:) (Expenses \$ **322,673** including grants of\$) (Revenue \$ **245,452**)

Counseling Services: Professional therapy for children, families, and individuals. 375 clients received over 3,226 hours of therapy. 201 individuals attended educational classes taught by clinical staff for a combined total of 725 staff hours. 48 sessions of support groups ran for 72 hours. We continue to see impressive outcomes where 90% of clients in the Clinical Services department reported an increase in quality of life after using Family Support Center services.

LifeStart Village: Housing and self-sufficiency program for homeless single parents and their children. 229 individuals were served across all three phases of the program. Over 405 hours of case management and 293.50 hours of counseling were provided. 92% of single parents living in Phase I increased their Self-Sufficiency score during the year and 100% increased their earned income while living there.

Windermere Commercial Real Estate returned and brought over 130 volunteers who worked over 735 hours of service. Their group transformed LifeStart Village and gave the property a much needed makeover in preparation of our 15 year celebration. They donated over \$6,000 in materials making their total contribution to the agency \$21,000.

Crisis Nurseries: 24/7 free short-term childcare for families in crisis situations and children at-risk of abuse or neglect. 1,319 children made 9,329 visits to the crisis nursery, including 911 overnight stays, 9,124 meals, and over 52,670 hours of care. These service totals also include 138 families experiencing homelessness, who were provided with both daytime and overnight visits.
